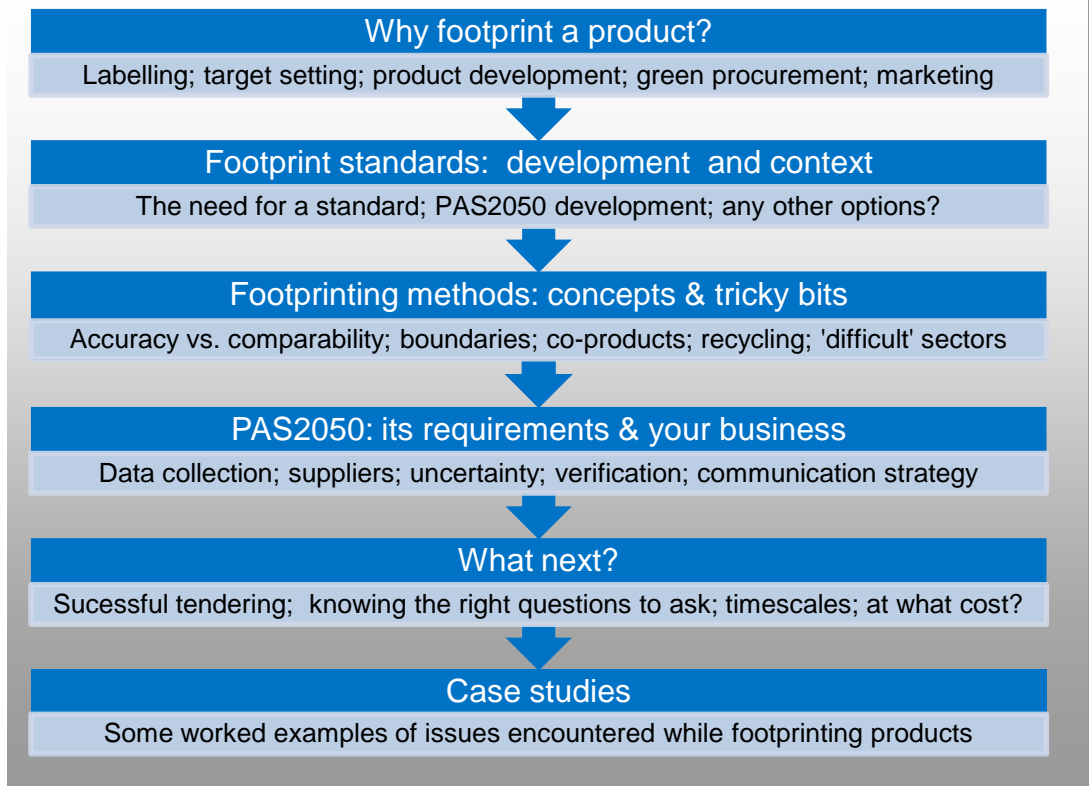


Understanding product carbon footprinting
